TOURNAMENT RULES:

- 1) All C.T.F. Tournament and Playing Rules will be strictly enforced.
- 2) All bowlers must be a member of the Lambton County Tenpin Association (L.C.T.A.) to participate. Any non-member may enter provided they pay the membership fee of \$25.00. If you are a member of another C.T.F. Association, an affiliate fee of \$5.00 is required.
- 3) Bowlers may participate more than once in this tournament. You can only cash once unless one (1) member of the team has been changed.
- 4) Bowlers must use their highest 2018-2019 yearbook average (C.T.F. or U.S.B.C.). If there is no yearbook average from the previous season, bowlers use their highest current sanctioned average based on a minimum of twenty-one (21) games as of February 1st, 2020. Bowler's with no applicable average will use 240.
- 5) Team handicap will be based on 100% of the difference in the team's average and 480 (240 per bowler).
- 6) Bowlers are responsible for verifying their own average, whether submitted by the bowler, the team captain or others, prior to the end of the first game. Failure to correct a lower average will disqualify the score.
- 7) All teams will start promptly with no make-up frames allowed. Teams are to report ½ hour prior to their designated bowling time to check-in and verify averages.
- 8) **YOUTH BOWLERS PARTICIPATING IN YOUTH LEAGUES WILL NOT BE PERMITTED TO BOWL IN THIS TOURNAMENT.**
- 9) The Tournament Director reserves the right to assign lanes on a first come first serve basis and the right to cancel and/or reschedule squad times.
- 10) **CTF Rule 319a (2) pertaining to the 10 pin improvement rule does apply for this Tournament. Bowlers must bring their league average sheet as of February 1st, 2020 at time of check in.**
- 11) Rule 319c is in effect - Average adjustment (rerating).
- 12) Rule 319d is in effect - Reporting prize monies and tournament scores within the last 12 months.
- 13) The Tournament Director's decisions in all matters pertaining to the tournament are final.
